

# Shepherd University Board of Governors

## Minutes of the Meeting of April 12, 2007

The Shepherd University Board of Governors met on April 12, 2007 in the Robert C. Byrd Center for Legislative Studies, Shepherd University, Shepherdstown, West Virginia, in a regular meeting.
