Minutes of the Meeting of August 15, 2007

The Shepherd University Board of Governors met on August 15, 2007 in the Robert C. Byrd Center for Legislative Studies, Shepherd University, Shepherdstown, West Virginia, in a regular meeting. Chair McMillan convened the meeting of the Board of Governors at 2:00 p.m.
