### Minutes of the Meeting of May 11, 2006

The Shepherd University Board of Governors met on May 11, 2006, in the Robert C. Byrd Center for Legislative Studies, Shepherd University, Shepherdstown, West Virginia, in a regular meeting. ### 1. MINUTES OF THE MEETING OF APRIL 13, 2006

#### 2. PRESIDENT'S REPORT
