Committee Reports

ACCE Yulia Freeman – HB 3279 ACCE is being proactive. They don't have a reason at this time as to why this was introduced.

PEIA will be going up 14%. If HB 2623 goes through it could eliminate PEIA or our insurance may have to go private. No one knows if there will be any federal money to help with this situation.

BOG Kevin Murphy – HB 3279 was introduce March 10th. As a way to show support for the university the Faculty Senate and SGA backed a resolution to reject HB 3279. A motion was made to support this resolution and passed. Barb will send this forward.

CEC Children Scholarship Fund Chris Silka – there is about \$1,150.00 to award for this upcoming school year.
