Provost DeRochi was the guest speaker. Academic Affairs and Scott Barton are working hand and hand with finance and business to build a best in practice for systemic transparency and financial reporting to be shared with faculty and staff in a consistent manner. Something in a visual way as to where we are budget-wise. The goal will be to move forward in a strategic and annual planning that can project out based on enrollment and what we see coming together in the future. We are looking at quarterly reports, monthly variance reports, taken from Banner. Displayed an Operational Analysis to compare several years of data. Financial Aid Services (FAS) have been secured to help us make good decisions with the financial aid leveraging. At the last BOG meeting discussion on getting the waiver committee started again. In June, Academic Affairs and Enrollment Management will be partnering up more closely on budget waivers. The total Budget Variance is up when compared to last year.

The Employee Salary Implementation Team (Dr. DeRochi, Scott Barton, Barb Kandalis, Larry Daily, Donna Shipley) has been formed to start addressing the salary compression here at Shepherd University. We need to reinvest net revenue or profits into our people, future growth, facilities and rainy-day safety net. Hope to have a visual ready by early fall. How do we grow if the growing team is underfunded? We must grow net revenue. It cannot be grown just through cuts. All of the above areas must be worked on. They work together.

### **Committee Reports**

**ACCE** Yulia Friman – the governor is calling a meeting about PEIA. Will be eliminated, increased or go private? Stay alert to new reports on this matter. We did lose the voting right for our CEC representative at the BOG meeting. It will be an advisory position only.

**BOG** Kevin Murphy – BOG met in April. Discussion about the salary compression. The faculty and staff compensation at Shepherd is below average when compared to peer institutions. Good news - enrollment numbers are up. Will seem confident that this trend will continue. He is watching the deposit money coming in, not just the applications. More transfer students are coming in and they tend to graduate. The budget is moving in the right direction. Kelly Hart has been hired as VP of Academic Development and will have 2 GAs to assist in the redevelopment of that office. Athletics dropped both the men's and women's tennis teams. Not sure what they

are doing with the waivers. Ground breaking for the new dining/athletic building will be this week.
