- A. Faculty workload guidelines (Senator Daily):
 - a. Workload determinations/calculations remain challenging due to variations in departments and disciplines. Discussion regarding the need for evaluating university service especially committee requirements and how scholarship requirements should be a priority and factored into workload. The current suggested workload percentages are flexible in the current draft as ranges. The ongoing goal of the draft is to come up with general guidelines that will then be handed down to the individual departments to be tailored to the specific disciplines. A suggested percentage change for the general expectation on the draft (Teaching: 75, Research and Scholarship: 15 and Service:10).
- B. Data access (Senator Murphy)
 - a. Data access questions are ongoing and a resolution is forthcoming
- C. Faculty Research Forum Committee (Senator Showen)
 - a. Senator Showen made a motion to establish a Faculty Research Forum steering committee within the Senate. Seconded by Senator Robertson: Discussed if we need to have the review of the committees first before we create another committee. Discussed a need to establish a proposal first to define what is needed. Senator Showen withdrew the motion.
 - b. All agreed the research forum is important however, it requires interest. A motion was made by Senator Robertson to create a committee to develop a proposal for the creation of a Faculty Research Forum committee. Seconded by Senator Showen. All approved.
 - i. Volunteers for the committee include; Senators Showen, Cline, Gordon, and Robertson. The group will report back to the Senate at the November 6, 2025 meeting.
