May 14, 2024, Classified Employee Council minutes

Minutes from the April meeting were approved. Barb Kandalis made the motion, Chris Silka seconded.

Dr. Marie DeWalt, associate vice president for human resources, was the guest speaker and discussed upcoming changes to the Fair Labor Standards Act (FSLA) and Higher Education Policy Commission (HEPC) salary rules.

Under current FSLA rules, workers earning less than \$684 per week (\$35,568 per year) are eligible for overtime pay. Most salaried workers who earn less than \$844 per week (\$43,888 per year) will become eligible for overtime pay starting July 1, 2024, under the final rule, and on January 1, 2025, most salaried workers who make less than \$1,128 per week (\$58,656 per year) will become eligible for overtime pay. Eligibility thresholds will be updated every three years, based on current wage data. The rule will also increase the total annual compensation requirement for highly compensated employees who are not entitled to overtime pay if certain requirements are met from \$107,432 per year to \$132,964 per year on July 1, 2024, and then set it to \$151,164 per year on Jan. 1, 2025. If these FSLA rules are not challenged in court and go into effect, it will increase the number of Shepherd employees required to clock in and out and move them into the status of being classified employees.

The HEPC also approved a new salary schedule for classified employees. The schedule is located on page 10 of the April 12, 2024 meeting agenda. It's not anticipated there will be money to fund this new salary schedule immediately.

Dr. DeWalt gave a report on these and other personnel issues during the April 18, 2024, Board of Governors meeting.

Yulia Friman submitted a report on the ACCE April 19, 2024, meeting: Updates from the Commission and Council – Brian Weingart, Senior Director of Financial Aid:

## State Aid Update

 Higher Education Grant – deadline extended to July 1<sup>st</sup> for 24-25 and maximum amount \$3,400

- Higher Education Grant award cycle May 1<sup>st</sup> and May 15<sup>th</sup>
- Promise Scholarship deadline extended to September 1<sup>st</sup> for 24-25 and maxim amount set \$5,500 starting Fall 2024
- First award cycle for new Promise recipients on a rolling basis.

## **Better FAFSA:**

Of the 24-25 FAFSA application that were filed through mid- April about 30% national wide had an issue:

- No SAI but no reject code
- Incorrect tax information from IRS
- Incorrect calculation of SAI

Another 15% were rejected because of student issue:

- Student indicated only wanted an Unsubsidized Stafford Loan
- Student indicated they could not provide parent information
- Missing signature or IRS consent

Updates from the Director of Classification and Compensation HR Division – Taran Wolford

 WV HEPC have launched a compensation study (market study) of all classified jobs.

There are plans to reconstitute the Special Safety Committee, which has not met since before the COVID pandemic started. Jenn Sirbaugh represents CEC on this committee.

Kevin Murphy, Board of Governors member, talked about what the board did during its April 18, 2024, meeting. Information about the meeting is available on the <u>Board of Governors</u> webpage.

Chris Silka discussed plans to take applications for the children's scholarship by June 1. The scholarship is now open to dependents of all staff members, with preference given to dependents of classified employees followed by former classified employees followed by other staff.

Chair Cecelia Mason's last day at Shepherd will be May 31, 2024. After that, vice chair Barb Kandalis will be in charge and an election will need to take place for a new chair, who will serve until June 30, 2025. The new chair will also automatically serve on the Shepherd University foundation Board of Directors.
